


Figur 2.5 Dagstidningsläsare samt tillgång till en prenumeration 9–79 år en genomsnittlig dag 2007–2014 (procent).

Press ethics

Report the news correct

- 1. Mass medias role in society and the publics trust of these media demands correct and comprehensive reporting.
- 2. Be critical of news sources. Control facts even if they have been published before. Make sure that the reader can separate facts and comments.
- 3. Headline and introduction should have full backing in the article.
- 4. Be careful with pictures

Respect personal integrity

- 7. Avoid publishing information that doesn't have an obvious interest for the public or is needed for public information
- 10. Do not emphasize a persons ethnicity, gender, nationality, political or religious stance, sexuality or profession if it's not important for the context of the article.



 - Avoid the use of the word immigrant
 - Born outside of Sweden

Refugee migration – Asylum seekers over time




"Media is hiding the truth"

Trust and truth

- Swedish public television 81% rely on the reporting
 - But 57% of the respondent who rely on SVT reporting thinks that media doesn't tell the truth about negative effects of immigration
 - 73% of respondent who **don't** rely on the reporting thinks that media doesn't tell the truth about negative effects of immigration
 - 82% of the respondents who thinks that media doesn't tell the truth about negative effects of immigration wants to limit immigration to Sweden





Migration agreement 23 October





Migration agreement

- Changing the length of the residence permit
 - Permanent residence permits to quota refugees, unaccompanied minors and families with children.
 - Temporary residence permits to other refugees, subsidiary protection and other protection.
- Amendment of the right to family reunification
 - At the temporary residence permit, refugees, subsidiary protection and others in need of protection have a right to family reunification comparable to that of under EU law.
 - Harsher finincial requirements for family reunification



Media on refugee crisis

- Report from think tank
 Tiden
 - Looked at all news coverage during 14 day period from Swedens four biggest papers
 - 76 articles under the theme "refugee crisis" in total 115 articles
 - Only 2 articles referred to the crisis outside of Sweden

The new migration law

- Temporary residence permits for all in need of protection except for quota refugees
 - Refugees should be granted a residence permit for 3 years
 - Subsidiary protection for 1 year
- The main rule should also in overtime be a temporary permit is granted
- Exceptions: Children and their families who have registered their application before the deal November 24, 2015. For those regards existing rules, provided that the child at the time the decision is still under 18 years old
- Other protection status shall not be entitled to a residence permit
 - Residence permit due to particularly / especially distressing circumstances replaced by a residence permit due. humanitarian reasons, in certain very limited exceptions.
- The government wants to medical age assessment of asylum-seekers applied



Limited right to family reunification

- Limited right to family reunification for the need of protection of limited duration
 - Refugees with temporary residence permits should only be reunited with his nuclear family. For spouses requires that both parties are at least 21 years.
 - Alternatively need of protection who have temporary residence permit shall not be entitled to family reunification.

Boarder control

- Temporary ID checks on all modes of public transport to Sweden
 - December 21, 2015 Law and Regulation on identity checks at the serious threat to public policy or internal security of the country
 - Was supposed to be there for 6 months, but we still have them

Swedish print journalism and the new law


- Over 400 articles on the new law from 2015-11-24 to 2016-06-20
 - Focus on the political strategic game
 - Describing consequences mainly for the Swedish system
 - Few articles interviews refugees who would be affected by the law
 - Critical voices mainly from body considering the proposed legislation
 - Reasons to the legislation:
 - The Governments picture of the situation
 - "The autumn 2015"
 - Refugee crisis



Opinion Polls

- Novus SVT 70% support the law
- Novus Red Cross 4
 of 10 know the law




